### Wednesday 10th December 2025

Today we venture to the wonderful NT Blickling Estate in nearby Aylsham. Here you can explore the Jacobean manor house beautifully decorated for Christmas. Perhaps enjoy a winter walk around the formal gardens or discover some of the 4,600 acres of land that makes up the estate. We return to our hotel mid afternoon with time to freshen up before dinner. ### Thursday 11th December 2025

After breakfast, we say goodbye to Norfolk and travel to the beautiful cathedral city of Ely. Perhaps explore the breathtaking cathedral (at own expense) or find one of the many artisan cafes or restaurants and enjoy lunch (at own expense). We then continue our journey home to Staffordshire. (B)
